3. Accounts and report on finances 2022–23

Our Treasurer reported on the accounts.

We gave £1510 of grants to PGR/unwaged members. Conference attendees were thanked for their generosity, as we received £780 from donations last year to enable this support. We have received less donations this year, and so a cash collection was also taken during the meeting.

The Society has £20,270 of reserves in the bank. This is to cover 3 or 4 years of BNTS running costs in case of conference cancellation etc. Please contact the Treasurer (tom.debruin@ru.nl) if you want to ask any questions.

The accounts were approved by acclamation.

4. Election of committee members for 2023–26

Secretary: The President thanked Michelle Fletcher for her work as Secretary over the last 3 years. She agreed to be re-appointed for a second term, and this was approved by acclamation.

Information Officer: The President announced that James Crossley was willing to stand as Information Officer for another year, completing his 3-year term. She thanked him for his work. He was re-appointed by acclamation.

Committee member. The President thanked Sydney Tooth for her 3 years of service.

Kelsie Rodenbiker was nominated by Sarah Parkhouse. Andy Byers was nominated by Steve Walton. An election was held, and Andy Byers was elected as committee member for 2023–26.

A question was raised about including attendees from the Republic of Ireland within BNTS membership. The Secretary said that this change in the Constitution would need to be voted on by members and the Charity Commission informed. The motion was supported and so next year's General Meeting will hold a vote on this matter.

a) Information Officer's Report

James Crossley reported on promoting the Society. The main activity has been social media promotion. Followers continue to rise: X/Twitter followers have increased by nearly 400 during the year. Facebook is a public group (with participants vetted for academic credentials and certain posts checked for appropriateness) and has increased by around 200 over the last year. X/Twitter continues to have the most activity, but Facebook also has regular activity. In both cases, this engagement continues to be overwhelmingly academic-related (promoting papers, books, conferences, interviews, etc.). The annual conference is integral to the use of the social media accounts. As with last year, the social media accounts have taken on an important function in helping coordinate alternative travel arrangements.
