GENERAL MEETING

Minutes

Friday 23 August 2024

4.30 pm University of Glasgow

Present: Helen Bond (President); Catrin Williams (Incoming President), Michelle Fletcher (Secretary), Tom de Bruin (Treasurer), James Crossley (Information Officer), Andrew Byers (TRS-UK rep), 57 members, 8 quests

The President welcomed members and guests to the meeting.

1. **Approval of Minutes:** 2023 meeting minutes were approved by a show of hands.

2. Matters arising

Andrew Byers reported on the recent meetings of TRS-UK, joining their Zoom meeting in March, then attending their day conference at the University of Birmingham in June. Anxieties over the future of TRS in UK universities has been voiced. There have been some signs of hope in recruitment of overseas MA students and relationships with RE Teachers and sixth-form colleges. It is clear that a significant recruitment pool for TRS applicants are religious communities. Overall, TRS-UK is doing some serious introspective work that will surely benefit BNTS members across the UK in their institutions.

3. Constitution Alteration

The President introduced a vote on altering the constitution to extend membership to residents of the Republic of Ireland, as previously circulated by the Secretary with the General Meeting notification. The vote was carried out by ballot papers overseen by the Treasurer. There was a unanimous vote to make this alteration. The new constitution is now available on our website.

4. Accounts and report on finances 2023–24

Our Treasurer reported on the accounts.

Income last year matched outgoings, and we end the year with similar general reserves as last year. The Treasurer raised the fact that although our accounts look quite healthy, costs continue to increase, including hosting the conference. The conference prices are likely to need to rise in coming years, and we are always looking for venues that would be willing to host.

The Treasurer thanked members for their donations of £429 in 2023 for the unwaged support. We received requests for 20 grants and paid £2450 to unwaged members. We

will continue to give out grants as long as the money continues but we are receiving far more requests than donations and so are transferring money between funds to cover this.

A cash collection was taken and bank account details shared. A total of £295 was collected, as well as £130 by bank transfer.

At year end, the Society had £18,048.13 of reserves in the bank, split over £3,346.50 in unwaged support and £14,701.63 in general reserves. The latter serves to guarantee 3–4 years of BNTS running costs in case of conference cancellation etc. Members were asked to contact the Treasurer (tom.debruin@ru.nl) if they have any further questions.

5. **Election of committee members for** 2024–27

President: The President stated that this was her final year in the role, and announced that Catrin Williams had been appointed as the new President. This was, as is the Society's process, by vote of the committee from a list of proposed names. Catrin Williams was appointed by acclamation. Paul Foster thanked Helen Bond for her time as President.

Committee members: Helen Bond thanked Garrick Allen and Elizabeth Corsar for their 3 years of service.

Cor Bennema was nominated by Steve Walton. Kelsie Rodenbiker was nominated by Martina Vercesi. Both were elected to the committee for 2024–27.

6. **Seminars**

Helen Bond informed the Society that the committee had been discussing how seminar groups are run, including the number of seminars and the units offered. The committee will continue to discuss this matter, running a seminar-chair meeting, and emailing the Society to gather feedback from members.

The Secretary thanked all the Seminar Chairs for their work.

The number of followers continues to rise year by year. X/Twitter: 2,975 followers. The public Facebook account (vetted for academic credentials/appropriateness) has around 2,700 members. X/Twitter has the most activity in terms of shares, likes, daily

engagements; Facebook has weekly activity. Twitter/X has more discussion/promotion of forthcoming BNTS papers; Facebook has more individuals promoting their work. The annual conference is a key focus, with a series of tweets dedicated to highlighting every BNTS 2024 paper.

The continued use of our social media is appreciated, and we encourage others to join in and send us your activities and achievements.

Helen Bond thanked James Crossley for his work, as he will be finishing his role at Christmas.
